Schools with a 0 in the last column: We did not have their device inventory at the time this document was produced. The exception is Bel-Air, they have turned in their inventory, however, they do not have any desktops or laptops. They do have 30 iPads, which have been approved for testing, but we do not recommend it due to the small screen size.

The Estimated Devices Needed is based on half of the students in the largest grade.
