**EVENT INFORMATION:** THE TOURNAMENT FORMAT IS MEDAL PLAY. USGA, NMAA AND LOCAL GOLF COURSE RULES APPLY; DETERMINATIONS SPECIFIC TO THE COURSE WILL BE MADE BY THE DIRECTOR OF GOLF AND GOLF COURSE STAFF. A RULES COMMITTEE OF THREE HEAD COACHES WILL BE DETERMINED BY CO-HOST SCHOOLS HEAD COACHES.

TEAM CHAMPIONSHIP TIES RE RESOLVED BY COMPARING THE TOTAL SCORES OF THE FIRST THREE INDIVIDUAL FINISHERS FROM THE TYING TEAMS. IF NECESSARY, THE SAME PROCEDURE WILL BE UTILIZED INVOLVING THE FIRST TWO FINISHERS AND FINALLY THE FIRST FINISHER UNTIL THE TIE IS RESOLVED. IF A TIE STILL EXISTS, A SCORECARD PLAYOFF IN WHICH INDIVIDUAL SCORES OF PLAYERS AMONG TIED TEAMS WILL BE COMPARED IN THE FOLLOWING ORDER UNTIL THE TIE IS RESOLVED:  
1. #1 PLAYERS ON HANDICAP HOLE 1  
2. #2 PLAYERS ON HANDICAP HOLE 1  
3. #3 PLAYERS ON HADICAP HOLE 1  
4. #4 PLAYERS ON HANDICAP HOLE 1  
5. REPEAT STEPS 1 THROUGH 4 USING SUBSEQUENT HANDICAP HOLES IN ORDER (E.G. HANDICAP HOLE 2, HANDICAP HOLE 3, ETC)

INDIVIDUAL CHAMPIONSHIP TIES ARE RESOLVED BY PLAYING HOLE NUMBER 9 IN A SUDDEN DEATH FORMAT UNTIL ALL TIES ARE RESOLVED.

POSTPONEMENT AND OR CANCELLATION OF THE EVENT DUE TO AN EMERGENCY, INCLIMENT WEATHER AND OR FACILITY/PLAYING CONDITIONS WILL BE IN ACCORDANCE WITH NFHS, NMAA AND APS GUIDELINES. AN ADJUSTMENT OF THE TOURNAMENT SCHEDULE OR THE CANCELLATION OF THE EVENT WILL BE DETERMINED AND ANNOUNCED BY THE APS ATHLETIC DEPARTMENT.
